Camping Agreement between campers – parents- staff:

- Camper must be ready to participate in group activities and learn new skills – get involved.
- Camper must respect staff and other campers. Bullying and other forms of disrespect are not permitted. If camper has a concern about another individual the camper will bring this concern to the staff for consideration.
- Camper recognizes the importance of respecting other people's ideas and values and tries to ensure everyone is included in activities.
- Camper must respect both their own and other campers property, including the camp's property (crafts, beds, cabins, etc.).
- There is no swearing, taunting, teasing, stealing, vandalism, or other unwanted behavior allowed at camp.
- All of the items listed on the packing list under unallowable items will not be brought to camp (example: knives, guns, drugs, lighters, illegal drugs, matches etc.). Immediate dismissal if found.
- Camper is willing and able to walk moderate distances over uneven surfaces.
- Camper is willing to be outside during seasonal weather including the heat and other elements (when safe).
- Camper won't litter and will help keep the camp environment clean including cabins.

Camp is a place to have fun and be you! Every camper deserves a safe and positive experience to grow his/her own problem solving skills, make new friends, learn how to work as part of a team, grow self-confidence /self-respect, learn to have fun in nature, and learn life skills. By signing this agreement the camper and parent confirm their willingness to comply with these standards and understand the consequences of failing to adhere to the conduct. SDFU reserves the right to dismiss without refund any camper whose presence is not having a positive impact on other campers or the organization. SDFU will dismiss all campers that bring inappropriate or illegal things to camp.

I grant permission to South Dakota Farmers Union, its agents, and its employees the irrevocable and unrestricted right to produce photographs and video taken of my child, myself, and members of my family while at South Dakota Farmers Union camp for any lawful purpose including publication, promotion, illustration, advertising, trade, or historical archive in any manner or in any medium. I hereby release South Dakota Farmers Union and its legal representatives from liability for any violation or claims relating to said images or video. Furthermore, I grant permission to use the statements of my child, myself, or my family members given during an interview or evaluation with or without my name for the purpose of advertising and publicity without restriction to time limit or geographic area. I waive my right, my child's rights, and my family's rights to any and all compensation stemming from the use of these materials. **Camper may still attend if picture permission is not granted. Special means will be taken to ensure photos are not taken of those who do not want them taken.**

I give my permission to have him/ her treated by a medical doctor in the case of serious injury/illness. If the person requires hospitalization, I understand my presence at the hospital is required as soon as possible. I understand that he/she will be properly supervised by arrangements and the total expense will be the responsibility of the youth's parents/legal guardian. I acknowledge that my child will follow the camper agreement and participate in the programs offered at camp. SDFU or its entities are not responsible for any accident/injury or lost/stolen items during the duration of the trip or camp. SDFU cannot be held responsible for information that is not disclosed honestly on this form. Some of the activities may include some risk including running, hiking, climbing, and other activities. I release SDFU and its entities and volunteers from and liabilities in case of injury.
